Consignment Contract

MERCHANDISE

A. Consignee agrees to the quality requirements set forth in the FJBC Sale Pamphlet including, but not limited to the following:

1. Clothes and other merchandise are clean and in excellent condition.
2. Large items are less than ten years old.
3. No consigned items are on a recall list.
4. All items have all pieces/parts and working batteries included.

B. Consignee takes full responsibility for checking for recalls on his/her items.

C. FJBC shall not be responsible for any loss of or damage to merchandise while it is under their control.

D. FJBC shall in no event be responsible for negligence of consignee.

E. Consignee agrees to consign a minimum of 15 tagged items in order to be eligible.

## SALE OF MERCHANDISE

- A. FJBC shall devote their best efforts to the sale and distribution of consignee's merchandise at the Sale.
- B. FJBC shall not be responsible for unsold items due to missing or stolen tags.
- C. All sale prices shall be fixed by the consignee.
- D. FJBC shall not sell consignee's merchandise at less than the authorized prices which will be specified on item tags.
- E. If price is not specified or not legible on an item's tag, FJBC reserves the right to fix the price and sell such item.

## COMPENSATION

- A. Consignee agrees to pay a \$10 non-refundable entry fee, due with this contract.
- B. Within three weeks of the Sale's end, FJBC will remit two-thirds (66%) of consignee's sales to consignee via mail. One-third (33%) of sales will be donated to the FJBC Kindergarten Ministry.

## MANAGEMENT OF SALE

- A. FJBC shall have entire charge of the management and operation of the Sale; they shall furnish all equipment and provide volunteers to operate the Sale.
- B. Consignee reserves no supervision or control over FJBC and its facilities, volunteers, and methods to be used and employed by FJBC in carrying out the purposes of this agreement.

## TITLE TO MERCHANDISE

- A. Consigned merchandise shall remain the property of the consignee until sold in the regular course of business.
- B. Items not picked up by 2:30pm on Saturday, May 3<sup>rd</sup>, 2008 will be donated regardless of how they are marked.
